## FCA ARROWSMITH CHAPTER DIGITAL ENTRIES

The FCA in Vancouver requires that digital images sent for jurying meet the following criteria:

1. Must be a true copy of the original art work in values, intensity and colour.
2. File format must be JPEG (.jpg) only. Non-JPG files will NOT be converted by the Gallery.
3. **Name file as follows: last name, first name or initial, title of work, size, (height first, then width) and medium. Example - Smith, R, Fresh Flowers,10x20,Acrylic.jpg**
4. Minimum 24-bit true colour or 8-bit gray scale for black & white images.
5. Image resolution must be at least 4" x 5" (1200 pixels x 1500 pixels) at 300 ppi. This high resolution is required for publishing work in Art Avenue magazine.
6. Recommended maximum image size is 2000 pixels on the largest dimension (either height or width).
7. Images must be cropped so that only the picture is visible.
8. Note: Poor quality images will be returned without being considered by the jury. Poor quality includes anything other than the art showing in the digital image. i.e. no frames, mats, easels, steps, etc. showing; images that are not square, over or underexposed, or with excessive glare from sun or flash.

1. **Attach** digital image file (.jpg) to an e-mail addressed to [silverisle@shaw.ca](mailto:silverisle@shaw.ca)
2. In the **subject line** of the e-mail put your name, and the title of the show.  
example: J Smith, Arrowsmith Fall Show, Image 1 of 3
3. **Check:** Make sure the image file is really attached \*Some e-mail programs resize images for sending. Ensure that your e-mail program is sending the image at full size..
4. **Send** images via e-mail to [silverisle@shaw.ca](mailto:silverisle@shaw.ca) (**Send only one image per e-mail. If you have three entries, send three separate e-mails**)
